



Thank you for entering the Sacramento Dog Training Club's AKC Agility trials to be held on December 1, 2 and 3, 2017. Event site is the Murieta Equestrian Center, 7200 Lone Pine Dr. Rancho Murieta, CA 95683.

Upon acceptance of your entry, you were emailed an entry confirmation. Please ensure you have reviewed that confirmation carefully and notify me at once with any corrections.

**MURIETA WAIVER:** The Murieta Equine Complex requires all persons taking part in activities on the property to sign the Murieta Release Waiver. If you did not send a signed waiver with your entry to any of the following 2017 AKC agility trials; Portuguese Water Dog Club, Sacramento Dog Training Club or TRACS, you must complete one and turn it into the scoring office before your first run of the weekend. A list of those owing waivers will be posted on the check-in table near the course maps. You must turn in a signed waiver BEFORE your first run of the weekend.

### **TRIAL SCHEDULE – GENERAL INFORMATION**

**MOVE-UPS:** In accordance with AKC rules, the move-up deadline for the trial on Friday, Dec 1, is 6pm, Monday November 27. No move-ups for Friday will be allowed after this time and date. Move-ups for Saturday and Sunday must be given to the Trial Secretary, in writing within 15 minutes of the last dog completing the course on Friday or Saturday for the subsequent day.

**JUDGING BEGINS:** Friday at 10am, Saturday at 9am and Sunday at 8am. See detailed schedule below

**CHECK-IN:** Opens at 9:30am on Friday, 8:30am on Saturday, and 7:30am on Sunday.

**WALK THROUGHS and JUDGES BRIEFING:** First walk through each day will begin no later than 15 minutes prior to the start of the first class. General Walk through in any ring may begin as soon as the judge approves the course. Subsequent classes and walk throughs will start when the previous class is completed. The initial judges briefings will take place 15 minutes prior to the start of the first class in each ring. Subsequent judges' briefings will immediately precede each class.

### **WALK THROUGH NOTES:**

**Novice and Open Std and JWW.** All heights walk together.  
**Novice and Open FAST will walk together and run FAST together.**

**T2B** All heights will walk the course together **before judging begins.**

**FAST Master/Excellent** All heights walk the course together **before judging begins.**

**Master/Excellent Standard and JWW** 3 walk through groups each day, as follows:

- 4/8/12
- 16
- 20/24

**RINGS:** The rings will be on dirt, under cover and will measure approximately 90 x 90. Both rings will be in Arena 3. All crating will be in Arena 4. See attached MEC map.

**SCORING, QUESTIONS and POSTING:** Scores will be posted in binders outside the scoring office as soon as possible after each jump height is completed. Please check your results as soon as possible, so we may resolve any questions before the judge forgets what your run was like! While it's true the score table is busy, we are never too busy to help you.

**AWARDS:** The awards table will be located in Arena 4 with the crating. In accordance with AKC regulations results aren't final until the judges have reviewed the class score sheets. Once results are final, labels will be printed, you may take your ribbon if the label has been printed. Master level dogs earning a Double, Triple or Quadruple Q will receive a corresponding pin. If you might earn a MACH at this trial, please let our Trial Secretary and/or Awards Coordinator Pat White know as soon as possible!

**COURSE MAPS** Course maps will be available near the awards table. Copies of the course maps are based on entry numbers, so please do not take a map unless you are in that class.

**MEASURING - HEIGHT CARDS:** All dogs, regardless of jump height, who are under two years of age and do not have a temporary height card or are over two years of age and do not have a permanent height card **must** be measured prior to their first run of the weekend. It is the exhibitor's responsibility to ensure that their dog is measured before their first run. Measurement of dogs will take place near the score table in Arena 3. In addition the the judges, Kathie Leggett will be available to measure for a permanent height card at this trial.

**CONFLICTS:** Conflicts will be handled as needed. If you think you might have a conflict, notify your GATE STEWARD before your class begins, or as soon as you know you have a problem. If you think that you might have a conflict due to working or running in another ring, then you can walk with an earlier group. However if you walk with an earlier group, you may NOT walk again.

**WORKERS:** Thank You for working, we could not run this trial without your help! Workers will receive raffle tickets and a \$2 ticket for each class worked. A worker appreciation raffle will be held Saturday and Sunday afternoon. The \$2 tickets can be used at the food concession, any vendors present at the trial, or for future SDTC trial entry fees. If you save your \$2 tickets for future entry fees, you must exchange the \$2 tickets for one voucher equal to the total of your \$2 tickets before you leave the site. The individual \$2 vouchers become worthless after the event.

**FOOD:** There will be an on-site concessionaire selling breakfast and lunch items. Complimentary coffee, and breakfast items will be available to competitors until 10:00 am each day. Hot water will be available all day. If you volunteer and are assigned to work, you will receive tickets you can use at the concession. If you are scheduled to work after lunch, be sure to track down your Ring Crew Chief in the morning and ask for your tickets!

**IMPORTANT COMPETITOR NOTE:** DO NOT, under any circumstances, allow your dog to relieve itself anywhere under, in or on the arena floor, structure, or anything man-made anywhere on the site. Additionally, be sure to pick up after your dog regardless of where or when they leave a mess. Failure to following these directions is cause for a Bench Committee hearing.

**DO NOT let your dog off leash anywhere on the trial site, except in the ring or at the warm up jump.** This is in accordance with AKC regulations and failure to adhere to this rule is also cause for a Bench Committee hearing.

### **TRICKS - TRICKS - TRICKS**

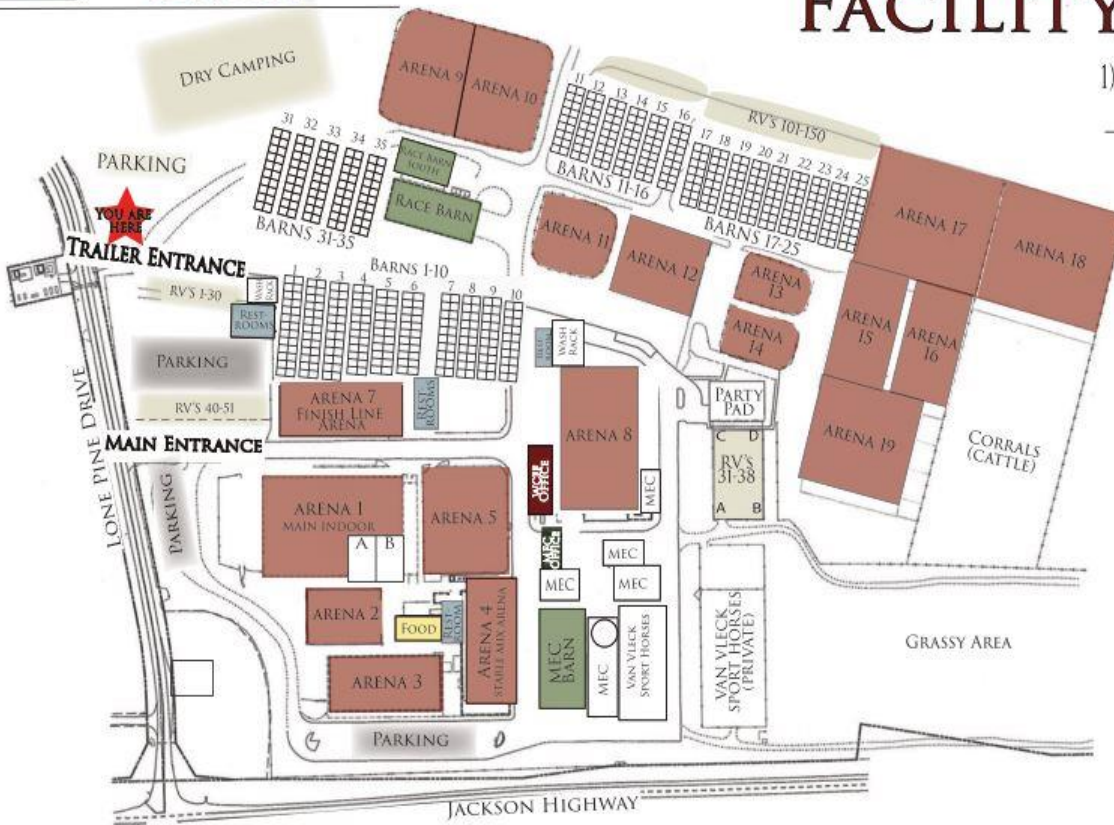
